

Safeguarding Training Policy

Specific Policy

This Safeguarding & Social (S&S) sub-policy controls safeguarding training for our church.

Introduction

Safeguarding training and resources in the Church of England are designed to equip our church to engage positively with the protection of children, young people and adults at risk in both a practical and theologically informed way. It exists to raise awareness of church policies for 'Ensuring a Safe Church for All' and to make individuals aware of their role and responsibilities in relation to recognising and reporting safeguarding concerns.

Training Provision

All training is provided via the Church of England or via the Diocese of Ely.

Core Training Pathways

Basic (approximately 1.5 hours online). Recommended for anyone who needs a basic level of awareness of safeguarding. This module is also a pre-requisite for attendance at any other core training module.

Foundations (approximately 1.5 hours online). Required for anyone who has safeguarding responsibilities/ contact with children and/ or vulnerable adults.

Leadership training (2 x 90 minutes online). Required for anyone who has safeguarding leadership responsibilities and/or leads activities involving children and/or vulnerable adults.

Additional Training courses

Raising Awareness of Domestic Abuse

This is an online course and can be accessed via The Church of England Training Portal.

Safer Recruitment and People Management

This is an online course and can be accessed via The Church of England Training Portal.

Modern Slavery and Human Trafficking

This is an online course and can be accessed via The Church of England Training Portal.
