

# **Data Privacy Notice Policy**



## All Saints' Church, Walsoken

## **Specific Policy**

This Safeguarding & Social (S&S) sub-policy controls Data Privacy Notifications at church. This policy may be distributed on demand.

#### **Personal Data**

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation (GDPR).

## **Procedure**

#### How do we Process your Personal Data

The PCC of All Saints' Church, Walsoken complies with its obligations under "GDPR" by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

#### Personal Data is used for the Following Purposes

- 1) To enable us to provide a voluntary service for the benefit of those in our parish.
- 2) To administer the electoral roll.
- 3) To fundraise and promote the interests of the charity.
- 4) To manage our congregation and volunteers.
- 5) To maintain our own accounts and records (including the processing of gift aid applications).
- 6) To inform you of news, events, activities and services running at All Saints' Church, Walsoken.

#### The Legal Basis for Processing your Personal Data

- 1) We need explicit consent of the data subject so that we can keep you informed about news, events, activities and services and keep you informed about diocesan events.
- 2) Processing is necessary for carrying out legal obligations in relation to Gift Aid.
- 3) Processing is carried out by church as a not-for-profit body.
  - a. The processing relates only to congregation members or former congregation members.
  - b. There is no disclosure to a third party without consent.

#### **Sharing Personal Data**

Your personal data will be treated as strictly confidential and will only be shared with other members of the church to carry out a service to other church members or for purposes connected with the church. We will only share your data with third parties outside of the parish with your consent.

### **Retention of Personal Data**

We keep data in accordance with the guidance set out in the guide "Keep or Bin: Care of Your Parish Records" which is available from the Church of England website. Specifically, we retain electoral roll data while it is still current; gift aid declarations and associated paperwork for up to 6 years after the calendar year to which they relate; and parish registers (baptisms, marriages, funerals) permanently.

## **Data Privacy Notice Policy**

### All Saints' Church – Walsoken

#### **Individual Rights and Personal Data**

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data: -

- 1) The right to request a copy of your personal data which the PCC of All Saints' Church, Walsoken holds about you
- 2) The right to request that the PCC of All Saints' Church, Walsoken corrects any personal data if it is found to be inaccurate or out of date
- 3) The right to request your personal data is erased where it is no longer necessary for the PCC of All Saints' Church, Walsoken to retain such data
- 4) The right to withdraw your consent to the processing at any time.
- 5) The right to request that the data controller provides the data subject with his/her personal data and where possible, to transmit that data directly to another data controller, (known as the right to data portability), (where applicable).
- 6) The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing.
- 7) The right to object to the processing of personal data.
- 8) The right to lodge a complaint with the Information Commissioners Office.

#### **Further Processing**

If your personal data is to be used for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.

#### **Purpose of this Privacy Notice**
